FastTrack refund policy

1. Cancellations for course enrolments must be made in writing (letter/fax or email) at least 7 days prior to commencement of training. In all cases a \$100 administration fee will be retained. Failure to give notice as per the above, will result in the full course fee being charged. However, students will have the option of transferring to the next available course by paying the \$100 administration fee. Please note that should a student who has transferred under these conditions subsequently cancel their course, no refund will be made.
2. In the case of Full Licence students, where the course is cancelled after commencement, a pro-rata refund will be made based on the individual unit price. In other words, the cost of individual units scheduled prior to cancellation or attended by contact class or received by DE will be deducted from the amount paid, and the balance refunded less a \$100 administration fee.
3. In all instances where materials need to be re-issued to any student, a \$50 per unit fee will apply.
